Sweepstakes begins at 12:00:00 p.m. Eastern Time (ET) on September 1, 2018 and ends October 31, 2018 at 11:59:59 p.m. (ET) ("Sweepstakes Period").

Eligibility and General Terms:** The Casey's Yeti ("Sweepstakes") is open to legal U.S. residents of the IA, IL, IN, KY, TN, AR, OK, MI, OH, MO, KS, NE, SD, ND, MN and WI states who are 18 years or older at the time of entry.
